TriCom Alert System 4 Contact Members Effectively via Phone, Fax, SMS & Email

Tips for Members

The TriCom Alert System has been developed primarily on a cost-only, non-profit basis, specifically for Crime Watch organizations. In order to receive your Crime Watch messages more effectively, here are a number of tips.

Receiving Phone Messages

If you have caller ID and can recognize an incoming phone call as being from your Crime Watch association, there are a few things you can do to receive the message more effectively.

After you answer the phone and say the customary "hello", you will hear an initial recording that says "The following is a rural crime watch message". At this point be quiet and do not continue to speak. The system needs two seconds of silence before it knows you are done speaking and it is okay to start playing the message. This is because answering machines often have longer messages, and the system needs to be able to start playing the message at the right time for both humans and answering machines.

Problems we sometimes encounter are:

- Continuing to say "hello": A person answers the phone, says "hello", hears the initial part of the recording that says "The following is a rural crime watch message", then repeats "hello" over and over again, then finally gets annoyed and hangs up. The system needs two seconds of silence before it knows the person is done talking, so in this case the member will get better results if they don't keep repeating the greeting.
- **Talking to someone else while listening":** A person answers the phone, hears the initial part of the recording that says "The following is a rural crime watch message", then begins talking to another person in the background. If the person does not cover the handset, the system hears the background conversation. The system will keep waiting until there is a two second pause in the background. If there is none, the message will never play. The solution to this is that if you get a call from Crime Watch, wait until the message actually starts before you start conversing with another person.
- **Excessive background noise:** It sometimes happens that a person has a TV, radio, or other sound source close to the phone when they answer. In this case, the system may not play the message because it never hears two consecutive seconds of silence. The solution to this is either cover the handset after saying "hello", or move farther away from the source of noise.
- **Line quality issues:** In rare cases a person will never be able to receive the message because their phone line has an unusual amount of background noise. In this unusual case, the only solution is either to use a different phone line, or receive messages via a medium other than phone.
- Voice mail & answering machines: If you find that messages from Crime Watch have the beginning cut off, the most common cause is that there is a long silence somewhere in the middle of your voice greeting. The easiest way to check is to call yourself from another phone and listen to your voice greeting. If there is a fairly long silence somewhere in the middle of your greeting, the solution to this is to re-record your voice message so as to remove the long period of silence. If you have the opposite problem, where the message starts fine but cuts out before it is finished, you probably have a "maximum message time" property on your answering service. The only solution in this case is to try to increase the maximum message time allowed by your answering service, or notify your Crime Watch administrator that you cannot receive long messages.

Remember that the system will not dial out at night; normally only between 08:00 - 21:00 (or whatever hours your association has set). If not complete by 21:00 it will pause and resume in the morning.

Receiving Other Message Types

There are definite advantages to using email and fax over phone/mobile as much as practicable. The information in them is persistent. You can print out that message about a stolen car and pin it somewhere, and refer to it weeks later without losing any of the relevant details. That is just not possible with non-persistent message methods (phone/mobile). For email, there is the advantage of much faster and more reliable delivery as well. Emails average better than 10 per second, whereas phone/fax/mobile takes hundreds of times longer to send. If there are 1000 people in your association to send a message to and all of them are receiving via phone/fax/mobile, the entire fan-out would take over 2 days to send across 2 phone lines. The same message, if all members were receiving it via email, would take about 2 minutes. So if you are in a position to receive emails rather than voice messages, it is advantageous for you to do so.

- Competent . trained drivers Hauling Augers
- Pilot vehicles not regulated but do your due diligence
- Recognize tires & rating for speed. A few minutes could be the difference between safe and NOT
