**p. SAFE COMMUNITIES (Kathleen Raines)**

SCCA's annual Young Farm Worker Safety Training Workshop is April 27 at Olds College. New to the program this year are half day sessions on grain entrapment and food safety. Following a Community Conversation on Youth Risk Management in November, a working committee has developed a pilot project entitled Youth Alive: A Comprehensive Youth Risk Management Strategy which we hope to present in one rural (Penhold Crossing) and one urban (Lindsay Thurber) high school over the coming year, dependent on securing funding. Partner commitments from the Red Deer Regional Hospital Emergency Department, Red Deer Emergency Services and Red Deer County Protective Services are in place to support program delivery.

Our Road Safety committee delivered a successful CarFit training and public clinic last April with very positive feedback. This program, designed by the Canadian Occupational Therapy Association and delivered by the Canadian Automobile Association, assesses the "fit" of senior drivers with their vehicles. We would like to train more CarFit technicians and deliver more clinics across the region this spring and fall, and are working on setting dates. Stay tuned for more details!
